2021 Annual Report Highlights: The Annual Report for 2021 was available to all present. Jane Newman made special mention of a couple of highlights:

- one was the completed porch and entryway renovation which has made the Museum more welcoming and more accessible to disabled visitors.
- she also stressed the extraordinary support that the Museum received during Covid from the BC Arts Council (beyond the usual grants received), and from the public as well.

- Cascades at Wild Cortes: Donna Collins spoke about the new exhibit which will open April 22 on Earth Day 2022. The exhibit will reflect on how climate change is affecting our natural world and continue to focus on "the big three" (apex predators, that are affected by climate change) which has been such a popular "hands on" exhibit. As much as possible, the exhibits are "hands on" and interactive.
